







Fig. 1 - Maximum Forward Current Derating Curve






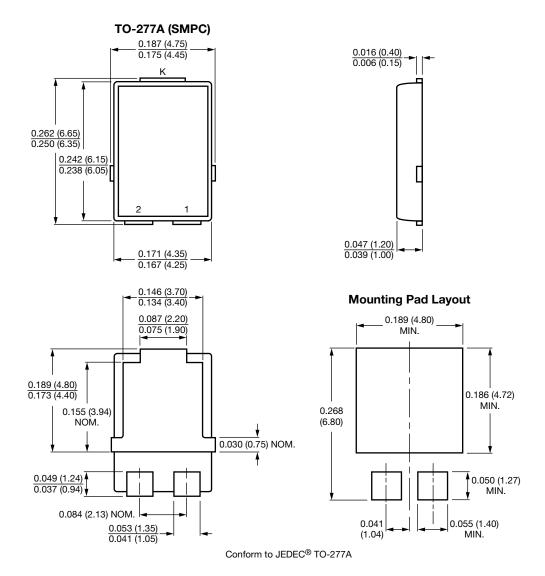
